The President's Message:

Fellow Surf Pines Homeowners,

Until lately, I didn't realize the large number of SPA members who volunteer to make our community such a great place. We have a large neighborhood and without the help of those volunteers, we'd be in a sad state. They maintain our member directory, greet new homeowners, plan annual events, deal with pesky scotch broom and sand burrs, assemble and edit The Breeze, prepare and maintain the reserve study, make recommendations to improve the financial solvency of SPA, manage our road maintenance, manage annual meeting covenants, participate in ad hoc and formal committees, etc. I have surely forgotten a few, but I speak for everyone when I say how much their work is appreciated. Without them, our dues would be significantly higher, and SPA would not look as stellar as it does today. More volunteers are always welcome and needed.

Last quarter, conference call access to our Board meetings commenced. There were two participants. If this proves beneficial to our members, we will continue it. Members who join in will need to identify themselves when prompted.

Attorney, Rich Vial's work load no longer allows him to manage the CCR work he was doing for us. The Board is now using Kyle Grant of the same law firm, the lawyer who administered our last annual meeting. His primary focus is homeowner associations, condominiums and relevant documents.

I expect the Board to review a proposal to move the CCR draft forward before the next Board meeting. The message from members is quite clear – no changes are wanted. That is exactly how they were drafted. I asked four members to review them for compliance to our directive of no change. Four agreed that they were virtually the same.

I will be sending out a letter to members explaining how we got into this predicament and how we expect the approval process to proceed. The work remaining is to authenticate our member list and update the legal description of Surf Pines. We believe a 75% affirmative vote is necessary for passage. A proxy service will be retained to manage and solicit the vote, and report back to us when the decision is conclusive.

This is likely the last Breeze you will receive in the mail, as we begin transitioning to a digital distribution. In the process of this and other activities, we realized that we have numerous databases of members for various applications. We intend to move to a single member database to populate all needs from the Breeze to member billing. Fewer than half of the members have provided email addresses with their contact information. **Please make sure your contact information is inclusive.** Confidentiality of that information to the general membership remains an option if desired. If organizations like Astoria Country Club can go digital, surely SPA can. As reported in the last meeting minutes, the amendment to our Articles of Incorporation allowing one vote per lot was approved and has been recorded with the State of Oregon.

There are 8 homes currently on the market in Surf Pines, 1 of which is currently sale pending. 12 parcels of vacant land are also available for sale, ranging in price from \$130,000 to \$275,000.

Since the last publication of this newsletter in mid-September, 4 homes have successfully sold within the Surf Pines community. These properties sold for an average of 90% of their original list price, and average market time was 250 days on the market.

Looking at the real estate market on a larger scale, new property listings in Clatsop County have been declining in number since September 2019. According to Clatsop MLS, average market time is 120 days and homes are selling for approximately 93% of their original list price. While mortgage rates are expected to remain reasonable into early 2020, limited housing inventory will likely continue to push prices higher, which may ultimately result in longer average market times for sellers, especially those who are selling higher-end properties.

1 cup packed brown sugar 3/4 cup butter, (1 1/2 cubes) room temperature 1/4 cup molasses 1 egg, room temperature

CHEWY MOLASSES COOKIES

2 1/4 cups flour2 t baking soda1 t cinnamon1 t ground ginger1/2 t ground cloves



1/2 t ground cloves1/8 t allspice1/8 t cardamon1/4 t salt3 T sugar

Using an electric mixer, bowl, and paddle, add brown sugar, butter, molasses and egg. Beat on medium speed for 2 minutes. Sift dry ingredients together, except for sugar. On low speed, add dry ingredients to molasses mixture, 1/4 cup at a time. Scrape down sides of bowl and paddle and beat for an additional 2 minutes.

Transfer dough to a smaller container with a tight fitting lid. Refrigerate for at least 1 hour, or over night. Preheat oven to 325° F. Shape dough into 1 1/2″ balls by rolling in your hands. Put sugar into a shallow bowl. Carefully, dip tops of dough into sugar. Place balls, sugar side up, on parchment lined cookie sheets, about 3 inches apart. Bake for 17-20 minutes or just until set and cookies appear dry. Slide parchment paper with cookies onto cooling rack. Let cookies cool for 15 minutes. They will be soft, but will firm up as they cool.

ROADS AND GROUNDS COMMITTEE

Trails:

We have added some large boulders near the Ocean Drive end of Trail 6 to prevent vehicles from entering Surf Pines Roadways if they come up the trail from the beach.

Roadways:

Trees and brush have been trimmed back; three feet back and 14 feet high. Signs have been replaced as needed. Reflectors have been replaced and curbs have been painted. We are working on the project bid documents for the next phase of Manion Drive widening north from High Surf Lane to the Lakeside Sea Breeze intersection.

Gates:

The gates are functioning without major problems, but continue to require daily maintenance. We are continuing work on an estimate to replace the gates with much lower maintenance requirements and trying to keep the project within the approved budget.
