## PER CLATSOP COUNTY PUBLIC HEALTH:

The County is working with Columbia Memorial Hospital, Providence Seaside Hospitals, pharmacies and other entities on a **coordinated plan** to ensure that [COVID-19] vaccines reach high-priority individuals in as timely a manner as possible, and to organize larger-scale vaccination events when the vaccines become available to the general public.

*At this time the vaccine is NOT available to the general public.*

THE SURVEY LINKS BELOW ARE INTENDED FOR THOSE WHO FALL INTO EITHER THE **1A, 1B OR PHASE 2 ESSENTIAL WORKER GROUPS** INTERESTED IN RECEIVING A VACCINE:

This survey is intended for Individuals who are in **Phase 1B** of the Oregon Vaccination Sequencing Plan. This includes *all childcare providers, early learning and K-12 educators/staff, and people over the age of 65*. You can also take this survey if you are *healthcare professional or medically-dependent person* in the **Phase 1A** group and have not been contacted to schedule your vaccine yet. [**Phase 1A** began December 2020: **Phase 1A Group 1** = Frontline HCP and LTCF residents; **Phase 1A Group 2** = Other Residential Facilities and HCPs; **Phase 1A Group 3** = Outpatient settings for High Risk Groups; **Phase 1A Group 4** = All other HCP]

This survey is intended for **Individuals** defined as part of **Phase 2 Groups**, which are defined as *critical workers, people of all ages with underlying conditions that put them at moderately higher risk, people in congregate settings and associated staff, and the general population*. [If you are an organization leader that wishes to register critical workers as a group, do not use this survey link. Please use the "Phase 2 Vaccination Interest Form (Groups)" below.]

This survey is intended for **Phase 2 Organizations (Groups)** in Clatsop County that identify as *critical workers* and wish to register as a group. *“Critical workers” are defined as those who work in industries essential to the functioning of society and environments with a substantially higher risk of exposure.* Other **Phase 2 Groups** include *people of all ages with underlying conditions, those live/work in congregate settings such as detention centers, and the general population.* [If you represent a critical worker organization that has asked employees to register themselves, or a Phase 2 citizen who doesn’t identify with an organization, do not use this survey link. Please use the “Phase 2 Vaccination Interest Form (Individuals)” previous block above.]
